Scope of work:

The scope consists of Capstone Business Simulation software and CompXM Business Competency Examination software (license and usage) for conducting Management Game course in MBA Programme at IIM Calcutta.

Capstone Business Simulation Software will be used for the Management Game course which will be taught in Term I and Term III, AY 2024-2025 for around 500 MBA students. This will have 90 logins to be set up and each login will enable a student team to login to the simulation for instructional purposes.

CompXM Business Competency Examination software will be required to conduct examinations in the Management Game course, and on two occasions, during July – September 2024 and during December 2024 – March, 2025 in the AY 2024-2025. License duration should be for at least 9 months.

The scope of work also consists of:

- a) Live real-time support for around 500 students and six Faculty members (including on Saturdays, Sundays and holidays) including phone and email support.
- b) Simulation back-end support for Faculty, including generation of reports, and scheduling for each section.
- c) Training for Faculty as will be required/determined by Faculty
- d) Complete set of Assurance of Learning reports and Global Comparators.

If any amount remains liable to be recovered by IIMC from the tenderer or in the event of termination of contract by IIMC on account of breach of any terms and conditions of the contract by the tenderer, the appropriate amount will be recovered from the PSD. No interest will be paid on PSD amount. It will be released after the defect liability period after thirty days of successful completion of the Contract whichever is later.
